1. **Application For Discover Membership Privileges.** The undersigned hereby applies for (check as applicable): a Club Discover Membership at Hampton Hall Club and/or a Golf Discover Membership at Hampton Hall Club and agrees to pay applicable monthly dues.

2. **Payment Of Membership Account.** All fees, food, beverage, merchandise, services and other charges of the Club charged to the member's account shall be due upon receipt and in no event later than the thirtieth day of the month in which the statement was mailed or emailed. The undersigned hereby agrees to pay all dues, fees, assessments, service charges, dining minimums (if any) and other charges incurred by the undersigned, immediate family members and their guests and to pay the Club account when due. Dues shall be payable in advance, on or before the first day of each month during the membership year, unless otherwise established by the Club. In addition, dining charges and other fees and charges at the Club will be billed on a monthly basis as determined by the Club and in such event shall be payable by the thirtieth day of each month. The dues, fees, service charges, dining minimums (if any) and other charges of the Club are subject to change from time to time in the discretion of the Club. Monthly statements reflecting all activity including all fees and charges incurred by the member and all payments received by the Club from the member will be closed on the last day of each month and will normally be mailed or emailed to the members of the Club within five days. All statements are due and payable upon receipt and in no event later than the thirtieth day of the month in which the statement was mailed. A late charge and/or interest may be added to all outstanding balances in accordance with the Rules and Regulations if the statement is not paid by the thirtieth day of the month. In addition, the Club reserves the right to place any member whose account is not paid in full by the thirtieth day of the month on a cash-only basis for any or all services and merchandise otherwise provided for credit at any time. The undersigned further agrees to pay all reasonable attorneys' fees, paraprofessional fees, investigation fees and other costs incurred in connection with the collection of delinquent accounts, upon trial and upon appeal.

The undersigned acknowledges and agrees that the Club requires that the undersigned provide to the Club a valid credit card/debit card account so that any amounts (i.e., membership fee, dues, fees, dining minimums (if any), assessments and other charges incurred at the Club) owed to the Club that are not paid by the undersigned in a timely manner may be charged to such credit card account without any further signature or authorization. The undersigned further understands it is their responsibility to keep a valid authorized credit card/debit card number on file with the Club at all times and to inform the Club of a change in the particular credit card/debit card to be charged. Upon placing a charge on the credit card/debit card account, the Club will inform the undersigned in writing of such charge.

Per Hampton Hall Club's Rules and Regulations for Short Term Rentals:

Tenants of Cottages may have access to the Club Facilities of Hampton Hall by purchase of a Club Discover Membership and/or a Golf Discover Membership. The Club Discover Membership is valid for 30 days and provides the Tenant access to all non-golf Club Facilities. The Club Discover Membership is renewable, and is available at the then current monthly rate for Club Dues plus Club Reserve Contribution. The Golf Discover Membership is valid for 60 days and provides the Tenant access to the Golf facilities. *One Golf Discover Membership may be purchased per Tenant, regardless of the term of the Tenant lease or number of leases by the Tenant, and is available at the then current monthly rate for Golf Discovery Memberships. The Tenant may enroll in either Membership at any time during the rental period. Pricing, terms and conditions are subject to change without notice.

Club Discover Membership entitles the Member, spouse and dependent children under age 23 use of the Community Clubhouse, Pete's Grill, tennis courts, fitness center, indoor and outdoor pools, playground, basketball court, and bocce courts for 30 days.

Golf Discover Membership entitles the Member, spouse and dependent children under age 23 unlimited rounds of golf and use of the practice facilities for 60 days.
