- ✚ Non-profit organizations with operating budgets of \$1,000,000 or less may apply for a grant
- ✚ Grant requests should not exceed \$5,000
- ✚ Grants will not be made to political or religious organizations, individuals, endowment campaigns, annual appeals or membership drives, or to cover marketing or advertising fees
